CWCCA'S PROCEDURE FOR JUDGING BEST OF BREED COMPETITION

Best of Breed judging as requested by 2017 National Specialty judge:

This class will be split, by sex, into groups of 10. Dog groups will be judged first, followed by bitches. There will NOT be a mass check in at the start of BOB judging. You will only be counted absent if you do not check in for your assigned group.

The Chief Ring Steward will break down the groups, in catalog order, and post them Wednesday evening. If you have more than one dog in a group, please advise the ring steward by 4 PM Thursday so you can be assigned separate groups.

The last group of each sex will include first place Veterans and Herding Titled plus any move-ups. Winners Dog and Winners Bitch will come in at the end with the final cuts.

Last minute changes may be made to accommodate Veteran or Herding class winners or WD/WB.

In the event that individual should make the cut with more than one exhibit, it is their responsibility to have alternate handlers available for their entries as would occur under normal judging procedures.

BREED CLASSIFICATIONS

*(Note – The Novice Breed Class is **NOT** being offered)*

* Bred-by-Exhibitor (BBE) Class Eligibility (Revised 09/02)

All dogs entered in the Bred-By-Class must be **individually registered** with the AKC. The person handling the dog must be the breeder of record of the dog and an owner of record of the dog. To exhibit in this class, family members must be a breeder and owner of record.

BEST OF BREED COMPETITION

NON-REGULAR CLASSES *(Involving Single Dog Entries)*

VETERAN DOG and VETERAN BITCH CLASSES – *(Divided by Age)*. The Veteran 7 – 9 class is for dogs and bitches, seven (7) years of age or older on the day of the show and less than nine (9) years of age. The Veteran 9 – 11 class is for dogs and bitches nine (9) years of age or older on the day of the show and less than eleven (11) years of age. The Veteran 11 and older class is for dogs and bitches eleven (11) year of age or older on the day of the show. Neutered dogs and spayed bitches may compete in the Veterans Classes at Independent Specialties. The winner of each of these classes will be eligible to compete for Best of Breed.

HERDING TITLED DOG and HERDING TITLED BITCH CLASSES

For any Cardigan Welsh Corgi that has acquired an AKC Herding title of record will be eligible for this class. The winner of these classes will be eligible to compete for Best of Breed.

Altered males or spayed bitches may NOT be exhibited in any single entry non-regular class except Veterans.

If entered in Veteran or Herding Titled Classes, they may **NOT** be exhibited in BOB if they are defeated in either the Veteran or Herding Titled non-regular class.

Instinct tests are a certificate, NOT a title and therefore do not qualify a dog for this class.

NON-REGULAR CLASSES *(Involving Multiple Dog Entries)*

STUD DOG CLASS is for Stud Dogs and two (2) of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. The Stud Dog cannot be shown as the Get for another Stud Dog. Owner of Stud Dog need not necessarily be the owner of Get. Offspring only to be judged based on their merits. Each dog making up the Get must be individually entered in one of the Regular Conformation Classes, Best of Breed Competition or a Non-Regular Conformation Class (*other than the Stud Dog Class*) at this show.

BROOD BITCH CLASS, same as for Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get where appropriate.

A castrated male may be entered as the Stud Dog in the Stud Dog Class and a spayed bitch may be entered as the Brood Bitch in the Brood Bitch Class.

BRACE CLASS, for two dogs that are similar in appearance, performing in unison and presented by a maximum of two handlers. Dogs competing in brace competitions must have at least one common owner. Dogs need not be entered in another class. Brace Class must be indicated on the entry form. If more than one brace is entered by common owners, the dogs comprising each Brace Unit must be designated "Brace #1, Brace #2, etc". Indicate on each entry form the AKC number/Registered name of the other member of the brace.

As the judge's decision in the Stud Dog, Brood Bitch and Brace Classes will be based on the merits of more than one dog or bitch, none of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class.

JUNIOR SHOWMANSHIP COMPETITION

Novice Junior 9 & under 12 yrs • Novice Intermediate 12 & under 15 yrs

Novice Senior 15 & under 18 yrs • Open Junior 9 & under 12 yrs

Open Intermediate 12 & under 15 yrs • Open Senior 15 & under 18 yrs • Master Class

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have won three (3) first place awards, with competition present, in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

When you or your agent sign the entry form, you automatically agree to the following terms concerning your stay in any hotel or motel during the duration of our Specialty. Exhibitors with Recreational vehicles should follow the rules as applicable. These rules have been established for the good of all exhibitors and help maintain a good relationship between the show community and the area hotels and motels.

- Dogs must not be bathed or groomed in the sleeping rooms. This will lead to severe clogging of drains, as well as housekeeping problems. The use of hotel linens for bathing dogs is not permitted. As a guest, you will be responsible for any damages that occur in your room.

- The grooming room will be locked overnight from 11:00PM to 6:00AM. There will be extra security on duty for the grooming room per the request of the CWCCA. Guests who leave dogs in the grooming room overnight will be doing so at their own risk. All dogs must prominently display an information card with contact information for you in the event that your dog needs your attention. The Lodge of Sawmill Creek Resort and management will not be responsible for the loss or damage to any dog or property of any exhibitor, whether the result of accident or any other cause. It is expressly understood that every dog is in the care and custody of his owner or handler during the time the dog is on the show premise.
- The CWCCA has contracted with both the photographer and videographer stipulating exclusive rights to imaging of our events. Imaging (still or motion) near the designated photo stand is prohibited.
- Ring side event imaging (still or motion) for redistribution without written pre-approval of contractors and the Event Committee is prohibited.
- Sales of any items and/or raffles are subject to the pre-approval of the Event Committee
- Every dog owner/agent is expected to pick up after their dogs. Please use the designated exercise areas only. Exercising will not be allowed near the main entrance, near the pool, volleyball courts, or golf course.
- Parking of vehicles in non designated parking spots will not be allowed. Anyone parking on the grass, golf course or along the road will be ticketed.
- Dogs are not permitted in the lobby, restaurant, swimming pool area, gift shop, or meeting rooms unless previously designated as a dog show area.
