Dogs must be kept crated or on leash except while competing or setting stock. \* No tying dogs to fences.

Do not allow your dog to harass or approach stock on site or on adjoining property.

Please pick up after your dog.

Unentered dogs permitted on site only with prior written permission of Trial Chair.

Failure to comply with any of the above is cause for removal from the event.

## ATTENTION EXHIBITORS

- There are livestock guardian dogs on the premises. These dogs are working dogs and should be ignored.
- Please keep all children under control and away from farm equipment, livestock, guardian dogs, and restricted areas.
- Please pick up after yourself and use trash cans on site.
- Only dogs eligible to be entered at this Test/Trial will be allowed within the Test/Trial limits except that testers/judges may use a trained backup dog in settling or controlling the stock.
- No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Telephone, telegraph, faxed, incomplete, or unsigned entries cannot be accepted. Entries cannot be accepted without entry fees.
- Funds drawn from Canadian banks add \$8 per check to cover processing fee. PNWHC apologizes to our Canadian friends. This is what we are being charged. Multiple entries may be combined on one check to minimize additional fees.
- Entries not on an official herding AKC entry form or photocopies of the entry forms without the Agreement and Rules on the reverse side of the official herding AKC entry form cannot be accepted.
- Bring your crates and appropriate wear for the weather. You will need chairs, umbrellas, canopies, or whatever else you may wish to pack to be comfortable. Port-A-Potties are available. Water is available for the dogs.
- Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian, judge or tester, or barred from competition by action of the Test/Trial Committee. If because of riots, civil disturbances, or other acts beyond the control of the management, it is impossible to open or complete the test/trial, no refund of entry will be made. Extreme weather conditions, including but not limited to snow storms, hurricanes, lightning, or extreme temperatures, must be considered for the health and safety of the dogs, livestock, exhibitors, judges, and spectators. The wellbeing of the dogs, livestock, exhibitors, judges, and spectators is of paramount importance. In the event it is necessary to cancel or stop this test/trial before completion, no refund of entry will be made.
- Returned checks do not constitute a valid entry. The secretary will add a collection fee of \$20.00 to the amount of each returned check. Returned checks may result in the maker's entries being accepted on a cash-only basis.
- No dogs may be entered in two classes on the same course with the same kind of stock under the same judge.
- The replacement value for damage to the facility (gates, obstacles, buckets, etc.) will be the replacement cost.
- **Replacement costs: Ducks-\$25, Sheep-\$150.**

Driving directions from PackLeader Farm: Return to 150<sup>th</sup> Ave and turn left onto Elgin Clifton Rd KPN/WA 302 for approx. 1.2 miles. Turn left onto WA 302 KPN/Gig Harbor-Long Branch Hwy for 5.3 miles. Turn left onto Purdy Dr NW/WA 302 for 1.0 miles and then merge onto WA 16 toward Bremerton for 11.3 miles. WA-16 becomes WA-3N and go 1.0 miles to 4091 State Hwy 3W, Bremerton, WA 98312.

**INJURY OR HEALTH PROBLEM WITH A PERSON:** The emergency response team for the area will be called immediately. Dial 911. A first-aid kit is on the premises. Nearby hospitals/emergency rooms are:
